WHAT IS A CERTIFICATE OF TRUST AND WHY IS IT IMPORTANT?

A *Certificate of Trust* is a legal document that serves to confirm the existence of a *Trust* and provides important information about its terms and conditions. It is commonly used in *Estate Planning* when a Trust is involved.

Below are some key uses of a Certificate of Trust:

- **1. Verification:** The Certificate of Trust is used to substantiate the existence of a Trust. It confirms that the Trust has been duly created and is currently in effect. Such confirmation is often required when conducting financial transactions, such as opening a bank account or transferring assets into the Trust.
- **2.** *Privacy: Trusts* are private documents, which are not required to be filed in Court unless there is litigation involving the *Trust*. Therefore, disclosing the entire *Trust* to third parties can be burdensome and may infringe on a Grantor's privacy. The *Certificate of Trust* affords a *Grantor* the ability to maintain confidentiality while still disclosing important information about the *Trust*.



3. *Trustee Authority, Powers and Duties:* The *Certificate of Trust* provides evidence of the Trustee's authority to act on behalf of the Trust, including the ability to buy, sell or manage assets held in the Trust. It can be presented to banks, financial institutions or other entities to help such third parties understand the scope of the *Trustee's* authority and responsibilities when engaging in transactions involving the *Trust*.

The exact requirements and specific contents of a *Certificate of Trust* may vary depending on the jurisdiction and the *Trust* involved. If you've got an older *Trust*, and no *Certificate of Trust* was prepared at the time you signed it, it might be worthwhile to contact us to discuss our preparation of a *Certificate of Trust* to summarize your *Trust* so you don't have to disclose more information than you'd prefer.
